#### 4. <u>PRESENTATION</u>

<u>Update - Facility Needs Assessment – Police Headquarters</u>

Mr. J. Stephenson, Principal – Form Studio Architects, and Mr. J. Pepper, Principal - RPL Architects presented a high level overview of the Police Headquarters Facility Needs Assessment Final Report, that had been previously presented to the Board in early 2020.

The Report included an assessment of needs for staff and floor space over a 25-year period, as well as cost estimates involved with the project. Slide 11 of the PowerPoint presentation noted that the cost estimates in the presentation are from 2020.

In response to questions from Board members, it was noted that extensive consultation, interviews and discussions with operational units, the Deputy Chief and the Chief of Police were conducted. Mr. Pepper confirmed that about 1/3 of the staff were interviewed about their working spaces.

Mr. J. Hannam advised that the previous Board confirmed the support of the recommended option - building a new site, and had submitted a budget for the entire build. That submission was later withdrawn, and a \$2.4M budget was submitted for the 2022 City budget. He noted that the \$2.4M submission has not been expended to date.

At 10:03 a.m., it was the consensus of the Board to resolve into Closed Session relative to Section 35 4(b) of the *Police Services Act*, RSO 1990 (relative to intimate financial or personal matters or other matters may be disclosed).

At 10:27 a.m., the Board reverted back into Open Session.

#### a) Honorarium for Board Members

Mr. J. Hannam, Secretary to the Thunder Bay Police Services Board, provided an overview relative to the above noted. He noted that there has been no change in honoraria since 2000.

Administrator M. Mercer noted that the Expert Panel recommended that it's important that the Board has the time and capacity to do their work, and also should be recognized for their work; however, the recommended amounts of honoraria are less than what the Expert Panel recommended. Administrator Mercer shared his view that this is a significant underpayment of the important work being done for the community.

With respect to the honorarium for members of the Thunder Bay Police Services Board, we recommend that honoraria be set at \$6,000 per annum for each member, and at \$7,000 for the Chair of the Board:

2023 Operational Budget: Second Quarter Variance Report

#### REPORT SUMMARY

To update the Thunder Bay Police Services Board on the status of the Operational Budget of the Thunder Bay Police Service as of June 30, 2023.

#### **BACKGROUND**

On a quarterly basis, Administration reviews the year-to-date revenues and expenditures and completes a forecast of the Thunder Bay Police Service's operating financial position to year-end (December 31, 2023). The forecast is compared to the 2023 approved operating budget and presented to the Thunder Bay Police Services Board.

The 2023 Net Operating Budget for the Thunder Bay Police Service was approved at \$52.2 million.

As of June 30, 2023, Administration is projecting an overall unfavourable variance of \$1.6 million. The key components of the unfavourable variance are discussed below.

#### **COMMENTS**

**Personnel Services** overall are estimated to be \$2.6 million unfavourable resulting from:

- A \$1 million unfavourable variance in wages and benefits resulting from the retirement entitlements of several senior sworn members as well as other anticipated payouts of accumulated vacation entitlements.
- Administration is also projecting a \$750,000 unfavourable variance in overtime and \$185,000 unfavourable variance in WSIB expenditures based on the trend to date, and,
- A \$630,000 unfavourable variance in paid duty wages. This variance however is recovered through User Fees which results in a net revenue to the Service. The estimated increase in Paid Duty activity is related to the continuation of paid duty services in the Emergency Department at the Thunder Bay Regional Health Science Centre which is continuing until March 31, 2024.

**Materials** are estimated to be \$93,000 unfavourable primarily resulting from additional software licensing costs for specialized software for Cyber Crime and Intelligence led activities, and additional equipment and project related expenses associated with additional funding received for Intelligence intiatives.

**Contracted Services** are estimated to be \$100,000 unfavourable primarily resulting from higher than expected legal fees.

**Provincial Grant revenues** are projected to be \$365,000 favourable as a result the timing of grant recognition for several project related grants, higher than budgeted Court Security and Prisoner Transportation grant and additional funding for Intelligence led initiatives.

**User Fees** are estimated to be \$741,000 favourable primarily due to the higher than estimated paid duty revenues.

The Police Services Act establishes a partnership between the Thunder Bay Police Service, the Police Services Board, members of the public, and the OIPRD to investigate and resolve public complaints.

The Professional Standards Branch of the Thunder Bay Police Service investigates public complaints assigned by the OIPRD, under Part V of the Police Services Act, with respect to:

- Officer conduct complaints
- Complaints about the service and policies of the Thunder Bay Police Service

At the conclusion of the investigation, the office of the Chief of Police will adjudicate the complaint. A substantiated officer conduct complaint may be dealt with by informal resolution or a Police Services Act Hearing. A substantiated service or policy complaint requires the Chief of Police report to the complainant, the Police Services Board and the OIPRD, on the resolution of the complaint. An unsubstantiated Officer conduct or policy/service complaint requires that no further action be commenced.

All steps in the public complaint process are subject to review by the OIPRD.

SUBJECT: Electronic Storage Detection (ESD) K9 – For information only

The purpose of this memo is to provide the Thunder Bay Police Services Board with information relative to Electronic Storage Detection K9.

Electronic Storage Detection K9 ("Cyber Dogs") have been in use by law enforcement since 2013. They are trained to detect a chemical used in circuit boards and memory storage which allows them to locate hidden or difficult to find storage devices at search warrants. As they do not have any protection or apprehension training, they are also able to provide emotional support to victims and to officers who engage in the difficult work of investigating child pornography offences.

These dogs are in use in the USA, Australia, SE Asia and in Canada.

A USA-based charity: Operation Underground Railroad (O.U.R.) will provide a trained dog, equipment and handler training at no cost to the service. The service will be responsible for vet bills, food and travel to training recertification, an estimated cost of \$3,800 yearly.

As the Thunder Bay Police Service Cyber Crime Unit is exceptionally active in Internet Exploitation investigations, the addition of a detection dog will enhance our ability to investigate these offences, put offenders before the courts and identify victims of crime. It is anticipated that the Thunder Bay Police Service will obtaining a ESD K9 in early 2024.

Early feedback from Peel Regional Police indicates that their ESD K9 located devices missed by search officers in 60% of the warrants in which she was utilized.

Additional information is attached to this memo for the Board's information.

#### **Electronic Storage Detection (ESD) K9**

These K9s are trained to indicate on the chemical compound that is in electronic storage devices such as SD Cards, Micro SD cards, thumb drives, external hard drives, iPads, cell phones, etc.

The K9s have also been utilized to assist in the de-escalation of a volatile scene, along with using the canines as comfort dogs during the interviews of victims, and as an office therapy K9 for the ICAC investigators.

The K9 is trained by Jordan Detection K9 who has partnered with Operation Underground Railroad (O.U.R.). O.U.R. is a non-profit that supports law enforcement in its efforts to combat online child exploitation and human trafficking. They work to ensure officers have the tools they need by donating ESD canines which help officers locate the necessary evidence to prosecute those who exploit children.

O.U.R. will provide the initial cost of the K9 (\$15,000), the initial 2-week Handler training course with Jordan Detection and the initial set-up cost for the dog (leashes, crush-proof kennel, harness etc).

#### Estimated Annual Operating Cost for an ESD K9.

Below is the estimated operating cost of an ESD dog.

Food	\$100 per Month (\$1200)
Vet	\$400
Total	\$1600

#### **Annual Recertification**

The annual recertification is 3 days in length with Jordan Detection K9 in Indianapolis Indiana. The Handler and the dog would be required to attend once a year. The cost of the course \$300 USD which is covered by O.U.R.. Because the dog would be required to attend it makes sense to drive from Thunder Bay to Indiana. The estimated costs associated with this travel are listed below.

### Subject: Medicolegal Autopsies from the Thunder Bay Region

We are writing to update you about the provision of medicolegal autopsies for the Thunder Bay Region, which is changing. The Thunder Bay Regional Health Sciences Centre (TBRHSC) has withdrawn medicolegal autopsy services effective June 30, 2023.

Thunder Bay stakeholders, particularly its Indigenous community, are concerned about inequitable service, the delays caused by transferring cases to the Provincial Forensic Pathology Unit (PFPU) in Toronto and the impact on cultural and religious practices. You, as police partners in death investigation, are also concerned about the quality of your investigations and the impact on your resources.

A decision has been made that all complex autopsies, including homicide, criminally suspicious, SIU and pediatric cases will continue to come to PFPU to ensure a quality of service consistent with that at the PFPU, such as the availability of forensic imaging. We understand that this will still place demands on your policing service. We want to assure you that the OFPS adheres to strict turnaround time guidelines for the performance of autopsies and release of bodies. We will continue to work with your police service to share timely information about cases and to minimize attendance at criminally suspicious autopsies.

We are implementing a plan to use the expertise and world-class talent of the PFPU to provide public service in the Thunder Bay region and continue to perform some medicolegal autopsies in Thunder Bay. The PFPU is introducing a Mobile Team strategy of limited deployment of PFPU staff to conduct some non-complex autopsies locally. The autopsy room at TBRHSC is available for the PFPU Mobile Teams to perform this work. Non-complex cases will be performed in Thunder Bay when a PFPU Mobile Team is present.

A PFPU Mobile Team will be in Thunder Bay approximately one week per month with Mondays and Fridays for travel. The first PFPU Mobile Team is scheduled for the week of August 28, 2023, with subsequent teams during the last week of each month, with some exceptions. We anticipate that this strategy will be in place for six to 12 months while other possibilities are explored.

This new strategy will allow us to continue to provide some non-complex medicolegal autopsies locally in Thunder Bay. We appreciate your support during the transition and welcome your feedback to continuously improve.

While the logistics might seem complicated, decisions about scheduling and location of autopsies will be addressed by the Regional Supervising Coroner in consultation with the Ontario Forensic Pathology Service. The Police Service Act, 1990, under Sections 143-148 sets out the requirement for the City of Thunder Bay to develop a Community Safety and Well Being Plan, including membership of a committee to carry out this work. That membership includes "A person who represents the board of the municipality...".

The Thunder Bay Police Services Board has been requested, by the City of Thunder Bay, to appoint an individual to be its representative on the Community Safety & Well Being Committee.

As the Act does not specify that such a representative be a member of the Board, the Board may elect to appoint a community member to be its representative. In reviewing the membership of the Committee it is notable that there is not a seat for a community at-large member, rather the Committee is largely made up of organizational representatives, including the Chief of Police.

Administration recommends that the Board consider appointed a community member to be its representative to this Committee.

The purpose of this memorandum is to advise the Thunder Bay Police Services Board that in August of 2023 the Thunder Bay Police Service has applied for the Bail Compliance and Warrant Apprehension Grant and to ask that the Board consider an increase in compliment should the grant be successful.

Pending the successful outcome of this grant application, which is under review, it is our intention to create two (2) fully funded civilian positions.

One of these civilian positions would be responsible for creating enhanced bail briefs in our Criminal Investigations Branch. The second civilian position would be a Violent Crime Coordinator position that would work between Community Outreach and the Courthouse. This position would link offenders to outreach organizations to reduce recidivism.

Both of the above noted civilian positions would be fully funded under this grant for three (3) years.

Pending the successful outcome of the grant I would ask that the Thunder Bay Police Services Board consider approving the following motion:

With respect to the Bail Compliance and Warrant Apprehension Grant, the Thunder Bay Police Services Board approves increasing the compliment at the Thunder Bay Police Service by two (2) civilian positions that would be grant funded positions.

The POC FLP Grant is a three-year term, which will help provide greater sustainability of provincial funding for police services, as well as ensure grant recipients are able to effectively measure outcomes and demonstrate success of initiatives.

The Ministry of the Solicitor General continues to work with our policing and community partners to bring the *Community Safety and Policing Act, 2019* (CSPA) into force. This work includes developing the regulations required to operationalize the CSPA.

Your advice and guidance, including the feedback provided on proposals previously posted to <u>Ontario's Regulatory Registry (ORR)</u>, has greatly supported the regulatory development process.

Currently, the following regulations or regulation descriptions are available on the ORR for your comment and feedback:

- Adequate and Effective Policing (General);
  - Major Incident Response Plan [document incorporated by reference in the Adequate and Effective Policing (General) regulation];
- Response to Active Attacker Incidents (regulation description); and
- Amount Payable by Municipalities for Policing from Ontario Provincial Police.

Further regulations or regulation descriptions will be posted on the ORR throughout the summer. Please regularly review the ORR over the coming months for these updates.

The ministry is working towards a CSPA in-force date of **April 1, 2024**. The police sector should continue familiarizing itself with the CSPA to ensure timely compliance, preparedness, and operational readiness for this date. The ministry expects to have the majority of regulations finalized and filed by mid-late Fall 2023.

On June 21, 2023, the Governing Body Executive of Criminal Intelligence Service Ontario (CISO) raised the maximum allowable amount for the small-scale investigation/intelligence probe funded by CISO, from up to \$75,000 to up to \$150,000. This is available to all police services, and there are no limits to how many applications a police service can make. Each application will be reviewed based on the merits of the investigation or the investigative technology requested.

Police services are encouraged to apply for funding to support their investigations/investigative technologies at any time under the Gun and Gang Specialized Investigations Fund (GGISF) or the Greater Toronto Area/Greater Golden Horseshoe Investigations Fund (GTAGGHIF).

Furthermore, new measures were announced on May 3, 2023, with the ministry adding a new package of initiatives and resources to combat auto theft crimes across the province. As part of this announcement, the ministry will continue to make the GTAGGHIF, initially announced in 2019, available for an additional three years.

On May 8, 2023, as part of a joint announcement by the federal and provincial governments, funds to support continuation of the province's response to gun-and-gang violence were announced.

The expansion of the BCT program at the OPC will allow more opportunities for training and support for police services in their efforts to recruit and teach the candidates they need to serve their communities.

The increased capacity for training at the OPC follows other recent BCT enhancements including the expansion of the program from 60 to 66 days to accommodate enhanced instruction in immediate rapid deployment/active attacker and mental health response training for individuals in crisis. The college's mental health training for individuals in crisis provides officers with a solid foundation to work with on-the-ground, frontline supports like mobile crisis response teams that help police forces respond to mental health incidents in local communities.
