5. <u>PRESENTATION</u>

Our Call Video Series

Mr. S. Paradis, Media Relations Coordinator, presented the 11th episode of the Police Service's "Our Call" video series. The episode featured Constable Evan Haywood, who was involved with a bridge rescue. A woman in crisis was hanging off the bridge, over the icy waters of the Kaministiquia River. With the assistance of several civilians, Constable Haywood was able to pull the woman back over the railing to safety, where she was released to paramedics on the scene.

It was noted that the Our Call videos will be featured once every two months going forward.
