## 1. PRESENTATION

<u>Update</u> - Facility Needs Assessment – Police Headquarters

Mr. J. Stephenson, Principal – Form Studio Architects, and Mr. J. Pepper, Principal - RPL Architects presented a high level overview of the Police Headquarters Facility Needs Assessment Final Report, that had been previously presented to the Board in early 2020.

A confidential overview of potential locations for a new building, including pros and cons for each proposed site, was provided.

Ms. D. Paris, Director – Financial Services & Facilities, Thunder Bay Police Service, also responded to questions. She noted that \$2.4M remains in the budget; it would include hiring a project manager, securing a new site, and then hiring experts to develop a more detailed design.

Administrator M. Mercer asked the Board how they would like to proceed: do they want to move forward acquiring land for a new site? Mr. J. Hannam noted that the decision to acquire a new site would ultimately be made by the City.

Chief Fleury will take on the role in respect of Indigenous matters that the Expert Panel recommended be assigned to a new Deputy Chief. Some of the responsibilities of the Police Chief will be shifted to the Deputy Police Chief – Administration, once that position is filled.

Discussion was held relative to the pros and cons of hiring externally versus internally, as well as the benefits of rotating positions. Discussion was also held relative to persons in acting roles applying for the permanent position.

Chief Fleury responded to questions about learning opportunities for the Chief's support staff and how he will assist in developing their careers.

Chief Fleury to provide an updated version of the Performance Plan to the Secretary for further review by the Board.
