## 4. UPDATES FROM LEGAL COUNSEL

Mr. D. Jarvis, Filion Wakely Thorup Angeletti LLP, provided an overview of the outstanding grievances.

The grievance filed by the Senior Officers Association, relative to Georjann Morriseau, has been referred to arbitration. No date or arbitrator has been selected at this time.

The Firth grievance is close to being finalized at an agreed settlement of \$50,000. Mr. Jarvis is waiting for execution and completion of documentation by Firth and the Police Association.

One conciliation matter regarding a grievance related to Mike Dimini is scheduled for conciliation on December 6, 2023.

All Human Rights Tribunal complaints remain outstanding, with two (2) new applications being received. A brief overview of the new HRTO applications was provided.

In response to a question on costs involved with the multiple HRTO complaints/applications, Mr. Jarvis noted that the Human Rights Tribunal does not award costs for respondents seeking compensation.

Mr. D. Jarvis left the meeting at 9:25 a.m.

## Labour Relations Committee

## Appointment to Bargaining Team

Copies of the Thunder Bay Police Services Board Bargaining Protocol, as approved by the Board on October 17, 2023, were provided for the Board's information.

At the commencement of each term of the Board, a skills inventory is to be conducted on each member of the Board to identify what experience and expertise that individual members have with collective bargaining. The outcome of this assessment is to be used to assist it with forming a bargaining committee to carry out bargaining during the term of office. This skills inventory has yet to be completed.

As soon as is practical in the term of office, a bargaining committee of the Board shall be struck. The composition of the committee shall include two (2) members of the Board.

At the October 24, 2023 meeting of the Labour Relations Committee, having regard for the known experience and expertise of Board members and the requirements of the *Police Services Act*, a recommendation was made for the Board to appoint the Chair of the Labour Relations Committee and the Chair of the Thunder Bay Police Services Board to the Bargaining Committee.

Ms. D. Paris, Director – Financial Services & Facilities, Thunder Bay Police Service, provided an overview of the detailed budgets and responded to questions.

Chief Fleury and Ms. Paris did meet with the City's senior executive team to discuss the Police Service's budget.

Ms. Paris noted that the Police Service does not have a reserve fund of its own, and that the Board should consider this when planning, particularly for a new facility.

Deputy Chief of Police R. Hughes also provided an overview, and noted that the Police Service will be partnering with the OPP for four (4) positions. Those four positions will be fully funded by the OPP. Execution of a MOU is anticipated for next week. In this regard, Ms. Paris advised that the budget will be amended accordingly; this will result in a reduction in the tax base.

Discussion was held relative to WSIB individuals and possible re-training for those individuals for other job vacancies.

Mr. J. Hannam noted that he and the Chair and KPW Communications are developing a communication strategy for the Police Service budget. This will involve the Chief and Board Chair participating in interviews, handling the release of the budget in a proactive way.

# b) Legal Services – Contract Renewal

On August 14, 2019, the proposal from the firm Filion Wakely Thorup Angeletti LLP was accepted in strict accordance with the terms and conditions set out in RPF-55 Legal Services for the Thunder Bay Police Services Board. There are 4 one-year options to renew this contract. The current contract expires December 31, 2023.

Mr. J. Hannam, Secretary to the Thunder Bay Police Services Board, provided an overview, responded to questions, and noted that this is the last year for the RFP for legal services. Early in 2024, the Board will need to determine how they want to retain legal counsel.
