4. UPDATES FROM LEGAL COUNSEL

Mr. D. Jarvis, Filion Wakely Thorup Angeletti LLP, reported that there was nothing material to report on since the December, 2023 Closed Session.

A brief overview was provided on the files he was working on. He noted that another HRTO complaint was received, and his office is working on a response. The response will be filed within the next two weeks.

Mr. Jarvis left the meeting at 9:10 a.m.

5. ORGANIZATION AND PERSONNEL

a) Update on the 2nd Deputy Chief of Police Position

Mr. J. Hannam provided an update on the search for the new Deputy Chief of Police – Administration. The Governance Committee is meeting with the recruiters on January 17, 2024 to further discuss the launching of the search. There was no new feedback from Board members on the job description. Board members were encouraged to submit any additional feedback by Friday, January 19, 2024.

It was noted that the job descriptions for the Chief of Police and the Deputy Chief of Police positions will have to be updated to align with the job description for the Deputy Chief of Police – Administration.

b) SIU Investigations

Report No. 01/24 (Police) relative to SIU Administrative Report – Section 32 - SIU Case #22-OFP-220, and Report No. 02/24 (Police) relative to SIU Administrative Report – Section 32 - SIU Case #23-OCI-295, were provided for the Board's information.

Inspector G. Snyder provided a verbal overview of the above noted reports, and responded to questions. A verbal overview of the following investigations, as well as five (5) other outstanding investigations, was provided in Closed Session by Inspector Snyder.

SIU #23-OSA-509 Sexual Assault Allegation – December 20, 2023 received SIU

- notification. Incident date December 15, 2023;
- SIU #23-OSA-514 Sexual Assault Allegation December 20, 2023 received SIU notification. Incident date December 16, 2023;
- SIU #23-OOD-536 Other Death January 3, 2024 received SIU notification. Incident date December 30, 2023.

Inspector Snyder noted that, once the above investigations conclude, an investigative review by the Service will follow. As always, the Service is fully cooperating with the SIU as they conduct their investigations. The rate for charges is low; there has been a 15-year gap between officers being charged (as a result of SIU investigations).

He noted that the majority of complaints are disproven when the body worn videos are reviewed.

c) SIU News Release on Jenna Ostberg

Discussion was held relative to the initial SIU media release on the death of Jenna Ostberg, and the repercussions/impact on the Police Service and the Mayor's Office that followed.

As a result of Chief Fleury's actions with the SIU Director, a second media release was issued, correcting some of the information in the initial release.

Discussion followed on public relations and the need to publicize good stories when they happen.

6. GENERAL MATTERS

a) Greenshield Benefits

Mr. J. Hannam, Secretary, provided an update relative to the above noted. He noted that the grievance in this regard had been resolved; however, there are occasional issues with responses from Greenshield on benefit submissions. When benefits are denied, Mr. Hannam is contacted by the Police Association, and then he contacts Service HR and through them the City's HR Division for resolution.

b) Nominations for Victim Services Awards of Distinction

At the December 19, 2023 Regular Session, All Chiefs Memo Index No. 23-0077, relative to nominations for the 2023/2024 Attorney General's Victim Services Awards of Distinction, was provided for the Board's information.

Mr. J. Hannam, Secretary, reported that he is finalizing two (2) nominations on behalf of the Board: one for the DEK Foundation (support for individuals in recovery from addictions) and one for the Thunder Bay and Area Victim Services. He has received input from both organizations and will be submitting the nominations in due course.

Mr. J. Hannam, Secretary, provided an overview relative to the above noted. He noted that the legal costs aren't paid until the outcome of cases is arrived at. If the officer is found guilty, the officer is not indemnified with his legal costs.
