## e) Request for Indemnification

Correspondence to Chair Karen Machado and Secretary John Hannam from Jeremy Pearson, Secretary – Thunder Bay Senior Officers Association, dated April 12, 2024, relative to a request for indemnification for former SOA member Holly Walbourne, was provided for the Board's

information.

Mr. D. Jarvis, Filion Wakely Thorup Angeletti LLP, provided background information and an overview of Ms. H. Walbourne's employment contract and history with the Thunder Bay Police Service.

He noted that Ms. Walbourne is not entitled to indemnification if she is not acquitted, and also noted that there is language referred to her acting in good faith in performing her duties. He recommended to the Board that they approach the Senior Officers Association (SOA) to clearly set out Ms. Walbourne's entitlements and exceptions. He also noted that Ms. Walbourne's contract provisions include the retention of a solicitor whose practice is in the City of Thunder Bay. The Board could say that they would like to negotiate an upfront rate for legal indemnification based on local legal fee rates.

Discussion followed on Ms. Walbourne's employment contract, Memorandum of Understanding, entitlements and conduct (acting in good faith in consideration of her profession).

Mayor K. Boshcoff entered the meeting at 9:46 a.m.

Chair K. Machado provided the Board with an overview of their options on this matter.

Mr. J. Hannam, Secretary, in response to a question, confirmed that former Chief of Police S. Hauth was informed that she would be indemnified in line with the costs of a Thunder Bay lawyer. Ms. Hauth has acknowledged that she will have pay the costs back if she is found guilty. Mr. Hannam is currently researching the costs of a good local defense lawyer in Thunder Bay.

Mr. Jarvis noted that it would be helpful to have an agreement signed that they will agree to pay back costs if not acquitted.

It was the consensus of the Board that more information is needed before they can make an informed decision.

Ms. K. Machado reported that the Bargaining Chair has presented a draft mandate of an up to 5 year contract and an up to 3.5% increase, compounding over each of the 5 years.

Mr. D. Jarvis noted that the Board needs to confirm a mandate for the Bargaining Chair and negotiating committee. Chair Machado noted that Bargaining Chair Bahlieda has done a lot of research, environmental scans and reached out to his contacts for other contract information and status out in the policing community.

Discussion followed on the length of the previous agreements and the proposed increases. It was noted that the increases for the Police Service should be compared to other police services in the province – not to increases for City employees (as the jobs are very different).
